8. PLANNING MATTERS:

Applications:

23/00720/F – amendment – creation of an EV charging zone and erection of canopy, substation enclosure and two jet bays and associated forecourt works at Hillington service Station on Lynn Road – it was decided to object to this application on the grounds of flooding, removal of the pedestrian access, which is used by residents accessing the shop, 1 of 2

parking for queuing vehicles waiting to access the forecourt – the new charging zones will remove the area for awaiting traffic and cause huge backlogs of traffic on the A148.

Proposed GR, seconded TK, and all in favour

23/01667/F – proposed redesign of 2 dwellings following the removal of the existing bungalow at Maltrow, Station Road - it was agreed to object to this redesign as the increase in the larger house to 3 stories is excessive, lack of car parking with a single drive and no turning bays. The scale of the larger property is out of proportion with the plot. Concerns also raised regarding the removal of mature trees with no defects.
