**4.1 KL&WN Borough Council:** Cllr. James Moriarty, as follows:

Very pleased with Cllr Dark as head of the Borough Council and JM appointed as Chairman of the Scrutiny body. Unanimous support given for the hospital rebuild. Latest update from planning regarding the proposed development at 22 Lynn Road clearly stated that the extension to the 6<sup>th</sup> of August was to consider Highways comments and the proposal would not be accepted. The Local Plan Review has Hillington as a designated rural village and the allocation for at least 5 dwellings in 2016 has been withdrawn by the landowner and removed from the review. The consultation period for the waste to energy at Wisbech has commenced. Regarding climate change, the Strategy in Action Plan commences in late autumn including de-carbonise of transport and pollination, working with Suffolk CC.
